In an effort to reduce errors, eliminate any cost to you for completion of your school property tax rebate form and, ultimately, process your rebate faster, the business manager and assistant business manager of the district will be available to assist you in filling out your school rebate form. The following dates have been set aside for form completion:

Tuesday, February 11, 2014	10:00 a.m. to 12:00 noon and 1:00 p.m. to 2:00 p.m.
Thursday, March 6, 2014	10:00 a.m. to 12:00 noon and 1:00 p.m. to 2:00 p.m.
Tuesday, March 25, 2014	10:00 a.m. to 12:00 noon and 1:00 p.m. to 2:00 p.m.
Thursday, April 24, 2014	10:00 a.m. to 12:00 noon and 1:00 p.m. to 2:00 p.m.

Please call (570) 402-1000 extension 1260 to schedule an appointment to have your school property tax rebate form completed. You will need to bring with you proof of all household income for the 2013 year (including social security and retirement, pensions, interest, dividends, rental income, IRA distributions, wages, unemployment compensation, etc.), your paid 2013 school property tax bill and proof of age (if this is the first time you have filed for the rebate). Copies of this information will be made here at the district so you can return home with your original documents. **NOTE:** You must also bring with you a copy of your completed 2013 PA1000 state property tax rebate form.

PLEASE NOTE: We ask that you enter the driveway that is directly across from the CITGO Gas Station. Please drive forward and park in the drive immediately in front of the district office building. Enter the door under the Blue Roof.

We hope you will avail yourself of this district-provided service. We look forward to scheduling your appointment.

The Pleasant Valley School District allows certain excess Homestead Property Tax Rebate for paid real estate property taxes as follows:

MAXIMUM REBATE cannot exceed \$500 on homestead only.

INSTRUCTIONS FOR 2013
SENIOR CITIZENS PROPERTY TAX REBATE

- COMPLETE PART A:** If this is your first application, provide proof of birth date and social security number. (You can use your birth certificate, PA driver's license, or PA identification card.)
- COMPLETE PART B:** Yes or No
- COMPLETE PART C:** Only the school taxes paid on the homestead residence in which you live are eligible for rebate. Include a copy of the property tax receipt for those paid taxes. A cancelled check is not acceptable.
- WHEN TO FILE:** After February 1, 2014, and **before June 1, 2014.**
- WHERE TO FILE:** Mail or bring your form to the district's Business Office at 2233 Route 115, Suite 100, Brodheadsville, PA 18322.
- ATTACH TO THIS FORM:** Attach the following documents, in order:
 - Signed copy of your state rebate form (PA-1000 Pennsylvania Property Tax or Rent Rebate).
 - Copy of your school tax receipt.
 - Copy of the documents supporting each income item shown on the state rebate form.
 - If this is your first application, copy of the proof of age.
