Dear Parents and Guardians:

All households with a child who was approved to receive free or reduced-price meals under the National School Lunch Program (NSLP) or the School Breakfast Program (SBP) with the last 12 months, including children who attend schools participating in the Community Eligibility Provision (CEP) are eligible for Affordable Connectivity Program (ACP) benefits. As Pleasant Valley School has been approved this school for the Community Eligibility Provision.

The ACP provides eligible households a discount of up to \$30 per month off their internet bills or \$75 per month for households living on Tribal lands, as well as a one-time \$100 discount off an eligible connected device.

In May, the Administration launched [GetInternet.gov](https://www.getinternet.gov)—a one-stop shop where Americans can check their eligibility, find fully covered plans, and sign up. About 13 million households have enrolled, but tens of millions more have not yet claimed their ACP benefit. We need your help to ensure all eligible families in your state sign up to save on their internet bills.

You are eligible for the ACP if you (or someone in your household) participate in one of these programs:

- Supplemental Nutrition Assistance Program (SNAP), formerly known as Food Stamps
- Medicaid
  - *Your Medicaid eligibility may be up for renewal. Learn more about [how to renew](#) (Spanish language information).*
- Special Supplemental Nutrition Program for Women, Infants, and Children (WIC)
- Supplemental Security Income (SSI)
- Federal Public Housing Assistance (FPHA) (including Housing Choice Voucher (HCV) Program (Section 8 Vouchers), Project-Based Rental Assistance (PBRA)/202/811, Public Housing, and Affordable Housing Programs for American Indians, Alaska Natives or Native Hawaiians)
- Veterans Pension and Survivors Benefit

- ***Free and Reduced-Price School Lunch Program or School Breakfast Program, including at U.S. Department of Agriculture (USDA) Community Eligibility Provision schools***
- Received a Federal Pell Grant in the current award year

You may need to show a card, letter, or official document as [proof that you participate](#) in one of these programs when you apply for the ACP.


